

# WCHS PFA Annual General Meeting 30<sup>th</sup> October 2019 Minutes

- 2. Minutes of previous meeting and matters arising- the minutes were agreed as correct and matters arising were related to either the summer showcase or centenary so all action completed with the exception of the PFA centenary event to be discussed at the meeting

### 3. <u>Chair's Report- Shaun Dawson</u>

Shaun opened the meeting by welcoming all attendees; He explained that the PFA is a registered charity and needs to adhere to Charity Commission guidelines re: governance and how it manages its affairs. 2018/19

- Funds raised £13k up from 11k the previous year
- £32k balance at the moment
- £15k for the centenary sculpture agreed
- PFA arrange many events /activities that also involve the girls and enhance their experience at WCHS including; Cake sales, Ice Iolly sales, sleep over, Movie night and Disco night. As well as other things like Boot sales and events for new parents.
- The last cake sale and Movie night were the most successful events to date
- Other Important fundraisers- Boot Sale, Jubilee Fund, Winston Bear are also key earners for PFA

- Supreme effort and commitment from 6-8 PFA volunteers + excellent team effort involving Jo/Colin and teaching/support staff and caretakers.
- 19/20- Great start with centenary weekend the highlight with some strong input from PFA to assist OGA as well as selling of souvenirs
- First term busy term as always with number of events between now and Christmas- volunteers are crucial - 7 events for new volunteers – this is critical for PFA to survive
- Past few years heavy investment into school £25k in the Innovation Lab; redecoration of the main hall, Food Tech equipment, instruments for Music department; sports equipment; Greek amphitheatre.
- 19/20- main focus from school is; Art & tech, School minibus (Emissions Zone factor from 2021), Picnic tables and benches and Screen and projector in the sports hall.

## 4. <u>Treasurer's Report</u> - Laetitia Dumbura

YE 2019 – summary of all fundraising and breakdown as per handouts from Treasurer (see attachments)

- Year on year movement shown and highlights show where we are increasing and losing funds from previous events last year
- Boot sale split income to see how much contribution from selling refreshments c/t other takings so we can see the benefit of selling refreshments and it's going up with new initiatives like selling toast etc.
- Summer showcase & other evening events- over £1000 raised last term
- Disco- last year good funds were raised -the same as the year before so on average £1000 profit per event
- Ice lolly sale- despite 2 cancelled (weather)— still made enough money so viable event and we hope to continue with this
- Jubilee fund- good income generator -some pay the money back into PFA so that's a bonus -Each month 3 prizes
- Sleepover good earner- last year was over £1000 this year we have sold over 40 tickets to date
- £13,140 last year's profit
- A few thank you gifts also shown as we have recognised some of valued contributions from those that have stepped down.
- 12 boxes of bears 6 sold at centenary event and other now being sold at events
- Merchandise coffee mugs bottles key rings- have sold well and seem to have been a good investment
- £3800 in total raised over the centenary weekend
- PFA suggest Parent pay- would be good to add so we can sell the rest.
- Figures do not include the sleepover and cake sale as yet this term
- Managed to sort out the funds with OGA huge task so been good to figure out sales

• The use of the card machine has been invaluable so has been a good investment

#### 5. <u>President's Report- Jo Pomeroy (Head teacher)</u>

Jo was very pleased to see everyone in attendance, as this is the annual general meeting, She provided a report on the year, rather than an update on the this term.

### • Results

**GCSE**: 78% of entries grades 9 - 7 (A\* or A). Progress too very strong. Our students on average made over one grade more progress than students nationally. (Progress 8 = +1.19)

**A-Level** 68% of entries graded at A\* - B with 42% at A\*/A.

8 Oxbridge places, 23 on medical training, 13 Economists etc.

Year transformation of computing – first A-Level entry this coming June. (NB Head of Creative Technologies reports a sea change in students currently starting out on GCSE courses and puts it down to their work as Digital Leaders and their ease in the Innovation Lab. They are fearless with Technology – problem solvers, not afraid of making mistakes)

• House drama – discussion around tickets and raffle collection by office so Nadia can produce a hamper

#### General fundraising idea's

- Food good idea was the general consensus
- Uniform second hand sales Jo is willing to consider but would need some more information as to how it will be managed – PFA to find out who is willing to lead on this and take this forward. Has run well in other schools but would need more PFA support that current members present cannot take on any further commitment, PE kit and gym kit – good uptake usually as not only do the girls lose a lot but good for parents to have an option to get elsewhere.
- Quiz night- suggested Nadia said that ICHS is running one and will feed back at the next meeting to say how successful this was
- There was a discussion on how to get more parents involved and support PFA, without the PFA School would struggle to provide some of the extras but the PFA committee and handful of helpers are not able to support every event without more support and getting new parents on board. Committee members are hoping that sleepover, house drama and disco will give them a chance to meet new parents and get them to give support.

Shaun explained that the PFA committee (4 members) had agreed to extend their committee size in order to serve the PFA better – the 4 main positions will remain but we will have an additional 2 without portfolio that will support the chair and committee. It is anticipated that we try to enlist Comms person- website, weekly bulletin, social media etc. as it was agreed that we could improve on getting more parents involved.
