Dear Parent / Carer

A updates and reminders:

Ofsted in the vicinity

Three secondary schools in the immediate area have been inspected thus far this term. We fully anticipate a visit (on fewer than 24 hours' notice) ourselves soon. Parents are informed immediately when an inspection is notified and asked to complete an on-line survey. I'd very much urge you to participate when the time comes. The greater the number of responses, the more indicative the views collated. Your support when the time comes will be very much appreciated.

Friday 8 October is a non-pupil Day

Parents are reminded that there is a staff training day scheduled this Friday and therefore no school for students.

Covid-19 safety

Positive cases remain low in the WCHS community but are rising in secondary school populations both locally and nationally. Parents are asked to reinforce messaging to students about the wearing of masks in corridors and busy communal spaces, about hygiene, about maintaining a sensible distance and about keeping spaces ventilated. Public Health England is asking secondary school pupils and teachers to continue twice weekly lateral flow testing for the remainder of the term.

Covid-19 vaccination for 12 - 15 year olds

We await information about the scheduling of the vaccination programme at WCHS. In the meantime we continue to urge parents to talk with their children about the issue and to access available information in order that an informed decision can be reached.

Availability of Home Test Kits

The high transmissibility of the Delta virus variant means that, to limit numbers isolating, it is more important than ever to identify cases early, before the infected individual is in school potentially passing the virus on to others.

We therefore seek your assistance and encourage all students to continue twice weekly testing during the remainder of this month. Students will have been issued with a new box of test kits for this purpose following round 2 of mass onsite testing.

We would also ask that you continue to report your test results whether negative, positive or Void to both the NHS via the NHS website https://www.gov.uk/report-covid19-result

In addition, please report the result to the school via our Microsoft form <u>Lateral Flow Test</u> <u>Home Reporting - STUDENTS (September 2021)</u>

Contacts who are not required to self-isolate from 16 August

From 16 August, you will not be required to self-isolate if you are notified you have had close contact with someone with COVID-19 and any of the following apply:

- you are fully vaccinated
- you are below the age of 18 years 6 months
- you have taken part in or are currently part of an approved COVID-19 vaccine trial
- you are not able to get vaccinated for medical reasons

Fully vaccinated means that you have been vaccinated with an MHRA approved COVID-19 vaccine in the UK, and at least 14 days have passed since you received the recommended doses of that vaccine.

All other persons should isolate for the required number of days

Should a member of your household test positive for COVID 19. You should take a PCR test even if you have no symptoms. Students should not attend school whilst they await the result of the PCR Test. If the results are negative, students can return to school but continue to take regular Lateral Flow Tests whilst members of their household with COID are isolating. If the PCR test result is positive, students should stay at home for the required isolation period.

We are writing to you in relation to the current police approach and enforcement regarding the unlawful use of E-Scooters. Officers are focusing on the unlawful use of all types of E-Scooters in a bid to improve user and pedestrian safety and road casualty reduction.

As you may know, it is currently illegal to ride any type of personally owned E-Scooter in any public place. We understand that buying a E-Scooter can be tempting, especially as they are so widely available now and are legal to buy/sell. However, the only place an E-Scooter can be used legally by anyone is on private land with the land owners permission. The reason for this is that E-Scooters are, for the purpose of current legislation treated as motor vehicles under the Road Traffic Act and are subject to the same legal requirements, including:

The driver must have a full driving licence

The driver must have an insurance policy

The vehicle must have been taxed

The vehicle must have an MOT certificate

It is not currently possible to get the above for privately owned e-scooters, making them illegal to use in public spaces.

You may have seen various pilot schemes being run across the country for the rental of E-Scooters and there are currently several which have started in parts of London. These pilots schemes are subject to exemptions as they are part of a Government trial and do not extend to the use personal scooters, even in the designated areas of the trials.

If your child is found using an E-Scooter on a road, pavement or any other public place such as parks, car parks etc, they face having their scooter seized by police and could be subject to prosecution under the Road Traffic Act for offences such as, but not limited to:

Driving otherwise than in accordance with a driving licence (6 to 8 Penalty points and up to £100 fine)

Driving without Insurance (3 to 6 Penalty points and up to £300 fine).

Driving / Riding other than on a road (Fixed penalty notice and up to £50 fine)

Contravening a cycle lane (Fixed penalty notice and up to £50 fine)

There may also be circumstances where offences are committed by parents, such as Permitting to drive without valid insurance or permitting to drive other than in accordance with a driving licence which could result in the parent being fined and given points on their own driving licence. The offences relate to any age of rider and it is irrelevant whether they are at an age where they can apply for a provisional licence or younger.

We are seeking your support in our approach to this initiative which is primarily aimed at safeguarding children as well as other members of the public/road users by reducing the unlawful use of these E-Scooters.

These music sessions will be on weekly, girls should bring their own instrument and no registration is required for the sessions.

REDBRIDGE MUSIC SERVICE

Remind your child to check their music timetable for their lessons, the timetables have been sent out. The information is also on the notice board by the hall and in the Jubilee rooms.

Music activities will be starting this week Monday 13th September apart from Senior choir which will start rehearsing on Thursday 9th. I would highly encourage people to attend as we have a wide variety of ambitious works, with all involved performing at our Christmas Concert on Thursday 7th December.

A brief description of musical activities:

String Orchestra: Open to all string players from grade 3 level and tackling classical repertoire.

Brass Ensemble: A visiting brass specialist from the Redbridge centre will be taking these, open to all brass players.

Junior Band: This ensemble is an excellent introduction to music at the school, available to all instruments and appropriate from novices up to roughly grade 3 equivalent standard.

Chamber groups: These are small ensembles which the music department will supervise and coach alongside proposed initiatives from students. I highly encourage anyone interested to speak to a member of the music department ahead of time to allow for planning.

Jazz Band: Mainly for years 10-13 instrumentalists, grade 4/5+ level - woodwind, brass, and rhythm section players (guitar, piano, bass, percussion) We play a range of swing, funk and pop tunes; encouraging learning to improvise confidently.

GCSE/A-level support: This is an ongoing class to aid any students taking the GCSE or A-level music course.

Senior Choir: A choir for all students in years 10-13, singing a wide variety of music from pop to jazz to classical. The Senior Choir performs at some of the school's traditional events – including the School Birthday coming up soon.

Junior Choir: A specialist vocal coach from the Redbridge Music Centre will be attending to lead this. It's an excellent opportunity for those in years 7-9 to attend regardless of prior experience.

Theory: These sessions provide a great boost in confidence for those who wish to understand the theoretical side of music not only to supplement music classes across all years, but also for aiding instrumental progress. Coaching will be based on ABRSM graded books, and will include anyone wishing to do their grade 5 theory exam, which is required for instrumental grade 6 and higher.

Orchestra: This is the main instrumental body of the school and is open to all relevant instruments of grade 4 equivalent standard or higher.

Redbridge Music Service (RMS) - Individual Music Lessons

Can parents please remind their daughters to check their lesson timetables and to make sure they attend their lessons. All students have been given their timetables. They are also on display on the RMS noticeboard by the Main Hall, in the Jubilee Rooms and on the notice board by the music rooms. Should they have any problem locating these they can speak to Mr. Ehigie in the office or email music@woodford.redbridge.sch.uk

Any students who wish to sign up for new music lessons need to contact RMS Directly, please be aware additional students will only be able to be added to lessons at the start of a term, therefore students now can request sign up for January lessons

What is Discord?

Discord is a chat room app commonly used by gamers, it is used to talk to other players while playing games. Users can send direct messages swap tips and advice with other players in game-specific servers (similar to online forums). Some games, like Fortnite and PUBG, have official verified Discords for fans to talk about the game.

Most significantly, you do not have to download an app to use it as it can be accessed via any browser and is free to use.

This is being shared with you to make you aware that the Discord social networking tool is geared towards adults, not children and young people.

STUDENT DROP OFF AND PICK UP

Parents **MUST NOT** drop their children off or pick them up by pulling into the main entrance gate at the front of the school. This entrance is for staff and school visitors only and not a drop off zone.

Parents are also stopping on the yellow zig-zag markings and double yellow lines on Woodford Green High Road which causes traffic problems on this very busy main road.

Parents **MUST NOT** wait, park or block access to and from neighbouring residential roads in particular Lodge Villas on the Woodford High Road.

Additionally parents are parking on the double yellow lines on The Charter Road and have even been observed pulling entirely onto the pavement at the junction of this road and Chingford Lane.

If you cannot safely drop or pick up your daughter on The Charter Road, parking is available at Sir James Hawkey Hall around the corner on The Terrace.

We appreciate traffic can be very busy at the start and end of the school day, but for the safety of all students, staff, parents and local residents, parents MUST park safely and considerately in marked bays or where parking restrictions otherwise allow.


